The assessment of dissection by centre supervisor

After the examination, the Centre Supervisor will assess each candidate's dissection according to the following scheme:

(a) Dissection Quality:

Good	=	Neat cut of the perivisceral wall or neat urinogenital cut	All organs required clearly displayed in order and visible
Average	=	Neat cut of the perivisceral wall or neat urinogenital cut	One or two organs required not displayed in order or not visible
Poor	=	Rough cut of perivisceral wall or no urinogenital cut	Most organs required not displayed in order or visible
Very poor	=	Very rough cut of perivisceral wall or no urinogenital cut	Organs required not displayed or visible
<b><i>Not applicable</i></b>	=	<b><i>Extensive damage to animal</i></b>	<b><i>No attempt to dissect animal</i></b>

(b) Drawing Accuracy:

**Accurate:** Drawing is true replica of dissection (even when very poor)

**Fairly accurate :** Drawing is close to dissection.

**Inaccurate:** Drawing is not representative of dissection.

**The assessment must be clearly written in the answer booklet of each candidate by the drawing of the dissection.**
